**ODH INCREASES FEES FOR COPYING A MEDICAL RECORD IN 2015**

ODH has recently increased the maximum limits on the amount that a healthcare provider or medical records company can charge in connection with providing a copy of a medical records. These 2015 rates are based on a 1.62% increase in the Consumer Price Index.

**PATIENT COPYING COSTS**

If the request for a medical record is made by a patient or the patient's personal representative, the total cost for copies may not exceed:

\$3.07 per page for first 10 pages

\$0.64 per page for pages 11-50

\$0.26 per page for pages 51 and higher

\$2.10 per page with respect to data resulting from an X-ray, MRI, or CAT scan, recorded on paper or film

+ Actual cost of postage

**COPY CHARGES OTHER THAN FOR THE PATIENT**

If the request for a medical record is made by someone other than the patient or patient's representative, the total cost for copies may not exceed:

\$18.91 Initial fee (to compensate for the records search)

\$1.24 per page for first 10 pages

\$0.64 per page for pages 11-50

\$0.26 per page for pages 51 and higher

\$2.10 per page with respect to data resulting from an X-ray, MRI, or CAT scan, recorded on paper or film

+ Actual cost of postage

**ENTITIES ENTITLED TO A FREE COPY OF THE MEDICAL RECORD**

A health care provider must provide one copy of the patient's medical record without charge to:

- Ohio Bureau of Workers' Compensation
- Ohio Industrial Commission
- Ohio Department of Job and Family Services
- Ohio Attorney General

Patient, patient's representative, or authorized person to support certain social security claims
